The Council on Foreign Relations
Congressman James E. Jeffries wrote, "If the Establishment is elusive in its identity, it certainly has a perceptible face in the Council on Foreign Relations..." Like its counterpart The Trilateral Commission, the CFR is composed of Wall Street investors, international bankers, foundation executives, members of Think Tanks and Tax-exempt Foundations, ambassadors, past and present presidents, secretaries of state, lobbyist lawyers, media owners, university presidents and professors, federal and supreme court judges, and members of military leaders from NATO and the pentagon.

The CFR is a supra-governmental organization that overshadows congress. It is financed by the Tax-exempt Foundations, and portrays itself as a humanitarian group. But its objectives are to erode national sovereignty and merge America into a worldwide government under the control of its members, which include people of tremendous wealth. Basically, their goal is global fascism. The CFR is responsible for setting major policy, which is activated without public knowledge or consent. It is beyond congressional investigation.

"Today the C.F.R remains active in working toward its final goal of a government over all of the world--a government which the Insiders and their allies will control. The goal of the C.F.R. is simply to abolish the United States with its constitutional guarantees of liberty. And they don't even try to hide it." Study No. 7, published by the CFR on November 25, 1959, advocates "building a new international order [which] must be responsive to world aspirations for peace, [and] for social and economic change." This new order will include, "states labeling themselves as 'Socialist' [Communist]."

Admiral Chester Ward, former Judge Advocate General of the U.S. Navy, remained in the CFR for about 20 years and co-authored a book entitled, *Kissinger on the Couch*, where he wrote, "Once the ruling members of the CFR have decided that the U.S. Government should adopt a particular policy, the very substantial research facilities of the CFR are put to work to develop arguments, intellectual and emotional, to support the new policy, and to confound and discredit, intellectually and politically, any opposition." The Admiral also warned that the goal of the CFR is the "submergence of US sovereignty and national independence into an all-powerful one-world government." In the August 1978 issue of *W Magazine*, former CFR President Winston Lord is quoted as saying, "The Trilateral Commission doesn't secretly run the world. The Council on Foreign Relations does that."

Jacob, who had become more involved in the offices more related to the direct affairs of The Intermediary, and ultimately, was asked to be The Secretary. ("The Secretary" being almost a title like "The Intermediary", he had often thought, because that was how everyone referred to him as soon as he took the position) was flying from from a secret meeting of the Council on Foreign Relations leadership as he continued to prepare the Intermediary's agenda for the Committee of 300 meeting with The Archons coming up in a few weeks.

He had opened his computer and entered his security codes to reach his Committee of 300 data. His eyes scanned the folders... the main folder of the 12 Domains which constitute the realms for each of the 12 Exousia. The Exousia, he had learned early on, were the Archons' "Delegated Authorities" who work closely with the "Apostolate", usually referred to as "The 12" - the top tier of the The 300. The 12, then, have their various subcommittees who coordinate activities of all the hundreds of groups, organizations, quasi-government and government agencies and international corporations who have expertise in the various 12 Domains.

He looked over the 12 individual folders for each of the Domains, to pick those that were to be discussed at the next Archon Council meeting in May...

He had finished the review of the new article for inclusion in their next Health Domain meeting - a group of medical ethicists linked to Oxford University -- ***After-birth abortion: why should the baby live?*** published in the *Journal of Medical Ethics*, says newborn babies are not “actual persons” and do not have a “moral right to life”. which had introduced a new paradigm in the healthcare debate, in which they boldly postulated that parents should be allowed to have their newborn babies killed because they are “morally irrelevant” and ending their lives was no different to abortion. The academics also argue that parents should be able to have their baby killed if it turns out to be disabled when it is born.

They argued: “The moral status of an infant is equivalent to that of a fetus in the sense that both lack those properties that justify the attribution of a right to life to an individual.”

Rather than being “actual persons”, newborns were “potential persons”. They explained: “Both a fetus and a newborn certainly are human beings and potential persons, but neither is a ‘person’ in the sense of ‘subject of a moral right to life’.

“We take ‘person’ to mean an individual who is capable of attributing to her own existence some (at least) basic value such that being deprived of this existence represents a loss to her.”

As such they argued it was “not possible to damage a newborn by preventing her from developing the potentiality to become a person in the morally relevant sense”.

The authors therefore concluded that “what we call ‘after-birth abortion’ (killing a newborn) should be permissible in all the cases where abortion is, including cases where the newborn is not disabled”.

They also argued that parents should be able to have the baby killed if it turned out to be disabled without their knowing before birth, for example citing that “only the 64 per cent of Down’s syndrome cases” in Europe are diagnosed by prenatal testing.

The article was another step in the process of implementing the policies presented by health policy advisor to President Obama Ezekiel Emanuel: **Deny Coverage to Elderly and Disabled for the Greater Good.**

Dr. Emanuel introduced the concept that doctors try too hard to apply the Hippocratic Oath to everyone as equally as possible, which is what drives up costs.

Emanuel introduced the need to ration basic, guaranteed care to only those who can fully participate in society in a [1996 Hastings Center](#) article in which he wrote this:

"This civic republican or deliberative democratic conception of the good provides both procedural and substantive insights for developing a just allocation of health care resources. Procedurally, it suggests the need for public forums to deliberate about which health services should be considered basic and should be socially guaranteed."

Substantively, it suggests services that promote the continuation of the polity-those that ensure healthy future generations, ensure development of practical reasoning skills, and ensure full and active participation by citizens in public deliberations are to be socially guaranteed as basic. Conversely, services provided to individuals who are irreversibly prevented from being or becoming participating citizens are not basic and should not be guaranteed.

An obvious example is not guaranteeing health services to patients with dementia. A less obvious example is guaranteeing neuropsychological services to ensure children with learning disabilities can read and learn to reason.

Dr. Ezekiel Emanuel, health care advisor to President Obama, had, according to the usual, and highly effective method developed in the Media Domain of publishing major policy articles and then letting them lie for a period of months or years and then building on them with other such articles before putting them into effect had adroitly argued that the elderly with dementia and the young who have neurological disorders should be sacrificed for the common good.

Next, Jacob turned to the folder titled "Spirituality", and clicked on one of the videos of a very successful approach that had been undertaken to subtly undermine the troublesome religions of Judaism, Christianity and Islam. They had battled with the irrational belief systems of Judaism and Christianity for eons, and had successfully controlled Islam for centuries, but they had a great resurgence over the past few decades, and were once again included in the attacks. While they were allowed to grow and thrive because they were useful in their anti-American and anti-Israel policies, they couldn't be allowed to get too big. The video was from the highly popular series "Ancient Aliens" that they were using to spread the UFO/Alien meme to disparage the major religions' belief in God and Angels.

Jacob was impressed at the rate of growth in the belief in aliens because of their efforts over the past 70 years, as evidenced by the article in his folder:

Reuters/Ipsos undertook a poll to measure the strength of human belief in extraterrestrial beings, and the results are astounding.

One out of every five persons believes in extraterrestrials is the conclusion of an [exhaustive poll](#) that saw 23,000 people canvassed in 22 countries.

While the majority of adults polled did not believe aliens were living here on earth, those polled in Asian nations expressed a strong belief that aliens, disguised as humans, are here. The poll results demonstrate men are more likely to believe in aliens than women.
