[Background from last week]

While Jacob, the Secretary to the Intermediary, continued to peruse his list of potential agenda items - the Arts, Economics, Education, Environment, Governance, Health, Infrastructure, Justice, Media, Relations, Science and Spirituality - to decide which were germane to the purpose, and gather reports to prepare the Intermediary's agenda for the Committee of 300 meeting with The Archons coming up in a few weeks, The Archons were preparing for a meeting of their own.

The Exousia, the Archons' "Delegated Authorities" who work closely with the "Apostolate",

While Jacob was concluding his review of the folder titled "Spirituality", and had watched with amusement the highly popular series "Ancient Aliens" that they were using to spread the UFO/Alien meme to disparage the major religions' belief in God and Angels, the meetings of the real Alien Angels were taking place in Heavenly Boardrooms on faraway planets.

These meetings were growing more and more optimistic - even excited - in tone, but with the rapidly growing success in their

War, the Chief One, generally addressed as The Shining One, was becoming more and more demanding, more and more critical, and more and more vicious in his ambitions.

He had summoned several of the Princes to come together to report on the Programs he had instituted in each of their Dominions - each of their Nations.

The Prince of the USA was, as usual, the primary participant in the meeting - both reporting and receiving new commands for his subordinates to institute.

The USA had been a focal point for the past 350 years, as they

watched its early settlers reach its shores and claim it for "Him", as they witnessed the dedication the early leaders had to "Him" and how the founding of the United States of America had, like Israel, been dedicated to serve Jehovah. From the earliest of days, The Shining One had identified the risk to their Rebellion that the newly forming nation could become.

The Prince at that time was of no great authority, watching over the Early Inhabitants of what was the North American Dominion - fostering their Idol Worship and directing Great Spirit worship toward the Shining One. This was the Global Agenda for The Rebellion and it had been almost perfect in its planning and execution; nearly the whole World was in their full control. There had always been small groups of The Faithful - the Jehovah Humans they called them, but not until Abraham received his promise of Nationhood had there been anything threatening to their Dominion. A nation whose purpose was to spread the Name

to all the human world could not be tolerated.

A Nation founded on Faith in Jehovah was the greatest threat since the Human Strategy had been introduced by Jehovah in the very Garden that had been the Headquarters of The Shining One and his faithful Legions. The very audacity of Jehovah to create an entirely new being on the very spot that The Chief had used to build his power to the point of proclaiming his Rebellion had been a huge psychological blow, but had been countered almost immediately with the turning of the allegiance of the First Two from

Jehovah to The Shining One. However, Jehovah had countered and they lost their allegiance, but the damage to their genes had been irretrievable, so the Victory was still theirs.

But the Nation to be called Israel, an entire nation of people dedicated to Jehovah, was a major upturn in the battle for the world. The Shining One threw everything he had to destroy them over the centuries and nearly succeeded on several occasions and they had been most ineffective in their "proselytizing". But then, hundreds of years after the nearly fatal loss at the Cross, a

second nation was on the horizon in the North American Dominion, and it had to be stopped. There was no telling what Jehovah had in mind for the new Nation that was to become the United States of America, but they all knew that any nation dedicated to Jehovah was a grave danger to the Rebellion.

There had been other nations who had been infiltrated by the so-called Good News, and many of these nations had been instrumental in its spread, but each had been overcome as their "Faith" turned to "Religion" and the Disciples had been corrupted

through the baited traps their Human Natures had so eagerly dragged them into. Each of the successive nations Jehovah had used to spread his Message were easily overcome in one manner or another, but none had ever been, at its Foundation, dedicated to Jesus Christ, as this new nation was.

1490-1492 – Columbus' commission was given to set out to find a new world.

According to Columbus' personal log, his purpose in seeking undiscovered worlds was to "bring the Gospel of Jesus Christ to the heathens. It was the Lord who put into my mind ... that it would be possible to sail from here to the Indies ... I am the most unworthy sinner, but I have cried out to the Lord for grace and mercy, and they have covered me completely ... No one should fear to undertake any task in the name of our Saviour, if it is just and if the intention is purely for His holy service." (Columbus' Book of

Prophecies)

April 10, 1606 – The Charter for the Virginia Colony read in part:

“To the glory of His divine Majesty, in propagating of the Christian religion to such people as yet live in ignorance of the true knowledge and worship of God.”

November 3, 1620 – King James I grants the Charter of the Plymouth council.

“In the hope thereby to advance the enlargement of the Christian religion, to the glory of God Almighty.”

November 11, 1620 – The Pilgrims sign the Mayflower

Compact aboard the Mayflower, in Plymouth harbor.

“For the glory of God and advancement of ye Christian faith ... doe by these presents solemnly & mutually in ye presence of God and one of another, covenant & combine our selves together into a civill body politick.”

March 4, 1629 – The first Charter of Massachusetts read in part:

“For the directing, ruling, and disposeing of all other Matters and Thinges, whereby our said People may be soe religiously, peaceable, and civilly governed, as their good life and orderlie Conversacon, maie wynn and

incite the Natives of the Country to the Knowledg and Obedience of the onlie true God and Savior of Mankinde, and the Christian Fayth, which in our Royall Intencon, and The Adventurers free profession, is the principall Ende of the Plantacion..”

January 14, 1638 – The towns of Hartford, Weathersfield and Windsor adopt the Fundamental Orders of Connecticut.

“To mayntayne and presearve the liberty and purity of the Gospell of our Lord Jesus, which we now professe...”

August 4, 1639 – The governing body of New Hampshire is

established.

“Considering with ourselves the holy will of God and our own necessity, that we should not live without wholesome laws and civil government among us, of which we are altogether destitute, do, in the name of Christ and in the sight of God, combine ourselves together to erect and set up among us such government as shall be, to our best discerning, agreeable to the will of God...”

September 26, 1642 – The rules and precepts that were to govern Harvard were set up.

“Let every Student be plainly instructed, and earnestly pressed

to consider well, the maine end of his life and studies is, to know God and Jesus Christ which is eternall life, John 17:3 and therefore to lay Christ in the bottome, as the only foundation of all sound knowledge and Learning. And seeing the Lord only giveth wisdome, Let every one seriously set himselfe by prayer in secret to seeke it of him Prov. 2.3.”

Harvard College was founded on Christi Gloriam and later dedicated Christo et Ecclesiae. The founders of Harvard believed that “all knowledge without Christ was vain.”

The charter of Yale University clearly expressed the purpose for

which the school was founded:
“Whereas several well disposed
and Publick spirited Persons of
their sincere Regard to & zeal for
upholding & propagating of the
Christian Protestant Religion ...
youth may be instructed in the Arts
& Sciences who through the
blessing of Almighty God may be
fitted for Publick employment both
in Church & Civil State.”

In addition to Harvard and Yale,
106 out of the first 108 schools in
America were founded on the
Christian faith.

April 3, 1644 – The New Haven
Colony adopts their charter.

“That the judicial laws of God, as

they were delivered by Moses ...
be a rule to all the courts in this
jurisdiction ...”

1647 – Governor William Bradford
publishes Of Plimouth Plantation.

“Lastly, (and which was not least,) a great hope and inward zeall they (the Pilgrims) had of laying some good foundation, or at least to make some way thereunto, for ye propagation and advancing of ye gospell or ye kingdom of Christ in those remote parts of ye world; yea, though they should be but stepping-stones unto others for ye performing of so great a work ... their desires were set on ye ways of God, and to employ his ordinances; but they rested on his

providence, and know whom they had beleeved.”

April 21, 1649 – The Maryland Toleration Act is passed.

“Be it therefor ... enacted ... that no person or persons whatsoever within this province ... professing to believe in Jesus Christ shall ... henceforth be any ways troubled, molested (or disapproved of) ... in respect of his or her religion nor in the free exercise thereof ...”

April 25, 1689 – The Great Law of Pennsylvania is passed.

“Whereas the glory of Almighty God and the good of mankind is the reason and the end of government ... therefore

government itself is a venerable ordinance of God ...”

May 20, 1775 – North Carolina passes the Mecklenburg County Resolutions.

“We hereby declare ourselves a free and independent people; are, and of a right ought to be, a sovereign and self-governing association, under control of no other power than that of our God and the general government of Congress.”

Summer 12, 1775 – Continental Congress issues a call to all citizens to fast and pray and confess their sin that the Lord might bless the land.

“And it is recommended to Christians of all denominations, to assemble for public worship, and to abstain from servile labor and recreation on said day.”

Summer 2-4, 1776 – Declaration of Independence written and signed.

“We hold these truths ... that all men are created equal, that they are endowed by their Creator with certain inalienable rights ... appealing to the Supreme Judge of the world ... And for the support of this Declaration, with firm reliance on the protection of Divine Providence...”

As the Declaration was being

signed, Samuel Adams said: “We have this day restored the Sovereign to Whom all men ought to be obedient. He reigns in heaven, and from the rising to the setting of the sun, let his kingdom come.”

On the same day, Benjamin Franklin suggested that the national motto be: “Rebellion to tyrants is obedience to God.”

Historian and philosopher G.K. Chesterton said of the founding of America that it is “the only nation in the world that is founded on a creed. That creed is set forth in dogmatic and even theological lucidity in the Declaration of Independence.”

September 17, 1787 – The Constitution of the United States is finished.

At least 50 out of the 55 men who framed the Constitution of the United States were professing Christians. (M.E. Bradford, A Worthy Company, Plymouth Rock Foundation., 1982).

Eleven of the first 13 States required faith in Jesus Christ and the Bible as qualification for holding public office.

The Constitution of each of the 50 States acknowledges and calls upon the Providence of God for the blessings of freedom.

1787 – James Madison, the

“architect” of the federal
Constitution and fourth president:

“We have staked the whole future
of American civilization, not upon
the power of government, far from
it. We have staked the future ..
upon the capacity of each and all
of us to govern ourselves, to
sustain ourselves, according to the
Ten Commandments of God.”

April 30, 1789 – Washington gives
his First Inaugural Address.

“My fervent supplications to that
Almighty Being Who rules over the
universe, Who presides in the
council of nations, and Whose
providential aid can supply every
human defect, that His benediction

may consecrate to the liberties and happiness of the people of the United States a government instituted by Himself for these essential purposes.”

March 11, 1792 – President George Washington:

“I am sure that never was a people who had more reason to acknowledge a Divine interposition in their affairs than those of the United States; and I should be pained to believe that they have forgotten that agency which so often manifested in the Revolution.”

December 20, 1820 – Daniel Webster, Plymouth

Massachusetts:

“Let us not forget the religious character of our origin. Our fathers brought hither their high veneration for the Christian religion. They journeyed by its light, and labored in its hope. They sought to incorporate ... and to diffuse its influence through all their institutions, civil, political and literary.”

July 4, 1821 – John Quincy Adams:

“The highest glory of the American Revolution was this: it connected, in one indissoluble bond, the principles of civil government with the principles of Christianity. From

the day of the Declaration ... they (the American people) were bound by the laws of God, which they all, and by the laws of the Gospel, which they nearly all, acknowledged as the rules of their conduct.”

1833 – Noah Webster:

“The religion which has introduced civil liberty, is the religion of Christ and his apostles ... This is genuine Christianity, and to this we owe our free constitutions and government ... the moral principles and precepts contained in the Scripture ought to form the basis of all our civil constitutions and laws.”

1841 – Alexis de Tocqueville
(Democracy in America):

“In the United States of America the sovereign authority is religious ... there is no other country in the world in which the Christian religion retains a greater influence over the souls of men than in America.”

Summer 8, 1845 – President Andrew Jackson asserts:

“The Bible is the rock upon which our Republic rests.”

February 11, 1861 – Abraham Lincoln, farewell at Springfield, Illinois:

“Unless the great God who

assisted (Washington) shall be with me and aid me, I must fail; but if the same Omniscient Mind and Mighty Arm that directed and protected him shall guide and support me, I shall not fail ... Let us all pray that the God of our fathers may not forsake us now.”

Lincoln on the Bible:

“In regard to this Great Book, I have but to say, it is the best gift God has given to man. All the good the Savior gave to the world was communicated through this book. But for it, we would not know right from wrong. All things most desirable for man’s welfare, here and hereafter, are to be found portrayed in it.” (George L.

Hunt, Calvinism and the Political Order, Westminster Press, 1965, p.33)

1884 – U.S. Supreme Court reiterates the Declaration’s reference to our rights as being God-given.

These inherent rights have never been more happily expressed than in the Declaration of Independence, “we hold these truths to be self-evident” that is, so plain that their truth is recognized upon their mere statement “that all men are endowed” – not by edicts of emperors, or by decrees of parliament, or acts of Congress, but “by their Creator with certain inalienable rights and that among

these are life, liberty, and the pursuit of happiness, and to secure these” – not grant them but secure them “governments are instituted among men.”

1891 – The U.S. Supreme Court restates that America is a “Christian Nation.”

“Our laws and our institutions must necessarily be based upon and embody the teachings of the Redeemer of mankind. It is impossible that it should be otherwise; and in this sense and to this extent our civilization and our institutions are emphatically Christian ... this is a religious people. This is historically true. From the discovery of this

continent to the present hour,
there is a single voice making this
affirmation ... we find everywhere
a clear definition of the same truth
... this is a Christian nation.”

(Church of the Holy Trinity vs.
United States, 143 US 457, 36 L
ed 226, Justice Brewer)

1909 – President Theodore
Roosevelt:

“After a week on perplexing
problems ... it does so rest my
soul to come into the house of The
Lord and to sing and mean it,
‘Holy, Holy, Holy, Lord God
Almighty’ ... (my) great joy and
glory that in occupying an exalted
position in the nation, I am
enabled, to preach the practical

moralties of the Bible to my fellow-countrymen and to hold up Christ as the hope and Savior of the world.” (Ferdinand C. Iglehart, Theodore Roosevelt – The Man As I knew Him, A.L. Burt, 1919)

1913 – President Woodrow Wilson:

“America was born to exemplify the devotion to the elements of righteousness which are derived from the Holy Scriptures.”

1952 – US Supreme Court defines the “Separation of Church and State.”

“We are a religious people and our institutions presuppose a Supreme Being ... No Constitutional

requirement makes it necessary for government to be hostile to religion and to throw its weight against the efforts to widen the scope of religious influence. The government must remain neutral when it comes to competition between sects ... The First Amendment, however, does not say that in every respect there shall be a separation of Church and State.”

January 20, 1977 – President Jimmy Carter:

“Here before me is the Bible used in the inauguration of our first President in 1789, and I have just taken the oath of office on the Bible my mother gave me just a

few years ago, opened to the timeless admonition from the ancient prophet Micah: ‘He hath showed thee, O man, what is good; and what does the Lord require of thee, but to do justly, and to love mercy, and to walk humbly with thy God’” (Micah 6:2).

1980 – President Ronald Reagan:

“The time has come to turn to God and reassert our trust in Him for the Healing of America ... our country is in need of and ready for a spiritual renewal.”

May 3, 1990 – President George Bush proclaims National Day of Prayer.

“The great faith that led our Nation’s Founding Fathers to pursue this bold experience in self-government has sustained us in uncertain and perilous times; it has given us strength to this very day. Like them, we do very well to recall our ‘firm reliance on the protection of Divine Providence,’ to give thanks for the freedom and prosperity this nation enjoys, and to pray for continued help and guidance from our wise and loving Creator.”

The Shining One had been obsessed with the Spiritual Dominion since the Beginning, and never so obsessed with the leadership of any nation since Israel as he has been with the USA. He had attempted to subvert them through every means at his disposal, and had met with great success; but the People had maintained their Faith in Jehovah and Jesus Christ and their presence had saved it through every attack. The One had attempted to destroy the USA through war and disease without success, and had determined that the only means to nullify its power was to destroy the Faith of the Jehovah People.

He had worked through the Churches; he had worked through the Legal System, he had worked to destroy every Church leader; and still their remained a Remnant, just as it had in Israel.

So, he had to reach the people of the USA through the very means that he would someday rule the World through his Man - his Replacement Christ – a Savior of the Nation, a charismatic man that he could promote through his control of the Media as the Architect of Change. Change, that the people would never question – just “Change” – and after they elected him, he would twist his own words to undermine the

Jehovah People by claiming his own “Christianity” and at the same time undermining every tenet of that Faith:

America’s Most Biblically-Hostile U. S. President

David Barton

When one observes President Obama’s unwillingness to accommodate America’s four-century long religious conscience protection through his attempts to require Catholics to go against their own doctrines and beliefs, one is tempted to say that he is anti-Catholic. But that characterization would not be correct. Although he has recently

singled out Catholics, he has equally targeted traditional Protestant beliefs over the past four years. So since he has attacked Catholics and Protestants, one is tempted to say that he is anti-Christian. But that, too, would be inaccurate. He has been equally disrespectful in his appalling treatment of religious Jews in general and Israel in particular. So perhaps the most accurate description of his antipathy toward Catholics, Protestants, religious Jews, and the Jewish nation would be to characterize him as anti-Biblical. And then when his hostility toward Biblical people of faith is contrasted with his preferential

treatment of Muslims and Muslim nations, it further strengthens the accuracy of the anti-Biblical descriptor. In fact, there have been numerous clearly documented times when his pro-Islam positions have been the cause of his anti-Biblical actions.

Listed below in chronological order are (1) numerous records of his attacks on Biblical persons or organizations; (2) examples of the hostility toward Biblical faith that have become evident in the past three years in the Obama-led military; (3) a listing of his open attacks on Biblical values; and finally (4) a listing of numerous incidents of his preferential

deference for Islam's activities and positions, including letting his Islamic advisors guide and influence his hostility toward people of Biblical faith.

1. Acts of hostility toward people of Biblical faith:

- April 2008 – Obama speaks disrespectfully of Christians, saying they “cling to guns or religion” and have an “antipathy to people who aren't like them.”
1
- February 2009 – Obama announces plans to revoke conscience protection for health workers who refuse to participate in medical activities that go against their beliefs,

- and fully implements the plan in February 2011. [2](#)
- April 2009 – When speaking at Georgetown University, Obama orders that a monogram symbolizing Jesus' name be covered when he is making his speech. [3](#)
 - May 2009 – Obama declines to host services for the National Prayer Day (a day established by federal law) at the White House. [4](#)
 - April 2009 – In a deliberate act of disrespect, Obama nominated three pro-abortion ambassadors to the Vatican; of course, the pro-life Vatican rejected all three. [5](#)
 - October 19, 2010 – Obama

- begins deliberately omitting the phrase about “the Creator” when quoting the Declaration of Independence – an omission he has made on no less than seven occasions. [6](#)
- November 2010 – Obama misquotes the National Motto, saying it is “E pluribus unum” rather than “In God We Trust” as established by federal law. [7](#)
 - January 2011 – After a federal law was passed to transfer a WWI Memorial in the Mojave Desert to private ownership, the U. S. Supreme Court ruled that the cross in the memorial could continue to stand, but the Obama administration refused

to allow the land to be transferred as required by law, and refused to allow the cross to be re-erected as ordered by the Court. 8

- February 2011 – Although he filled posts in the State Department, for more than two years Obama did not fill the post of religious freedom ambassador, an official that works against religious persecution across the world; he filled it only after heavy pressure from the public and from Congress. 9
- April 2011 – For the first time in American history, Obama urges passage of a non-discrimination law that does not contain hiring

- protections for religious groups, forcing religious organizations to hire according to federal mandates without regard to the dictates of their own faith, thus eliminating conscience protection in hiring. [10](#)
- August 2011 – The Obama administration releases its new health care rules that override religious conscience protections for medical workers in the areas of abortion and contraception. [11](#)
 - November 2011 – Obama opposes inclusion of President Franklin Roosevelt’s famous D-Day Prayer in the WWII Memorial. [12](#)
 - November 2011 – Unlike

- previous presidents, Obama studiously avoids any religious references in his Thanksgiving speech. [13](#)
- December 2011 – The Obama administration denigrates other countries' religious beliefs as an obstacle to radical homosexual rights. [14](#)
 - January 2012 – The Obama administration argues that the First Amendment provides no protection for churches and synagogues in hiring their pastors and rabbis. [15](#)
 - February 2012 – The Obama administration forgives student loans in exchange for public service, but announces it will no longer forgive student loans if

the public service is related to religion. 16

2. Acts of hostility from the Obama-led military toward people of Biblical faith:

- June 2011 – The Department of Veterans Affairs forbids references to God and Jesus during burial ceremonies at Houston National Cemetery. 17
- August 2011 – The Air Force stops teaching the Just War theory to officers in California because the course is taught by chaplains and is based on a philosophy introduced by St. Augustine in the third century AD – a theory long taught by

- civilized nations across the world (except America). 18
- September 2011 – Air Force Chief of Staff prohibits commanders from notifying airmen of programs and services available to them from chaplains. 19
- September 2011 – The Army issues guidelines for Walter Reed Medical Center stipulating that “No religious items (i.e. Bibles, reading materials and/or facts) are allowed to be given away or used during a visit.” 20
 - November 2011 – The Air Force Academy rescinds support for Operation Christmas Child, a program to send holiday gifts to

- impoverished children across the world, because the program is run by a Christian charity. [21](#)
- November 2011 – The Air Force Academy pays \$80,000 to add a Stonehenge-like worship center for pagans, druids, witches and Wiccans. [22](#)
 - February 2012 – The U. S. Military Academy at West Point disinvites three star Army general and decorated war hero Lieutenant General William G. (“Jerry”) Boykin (retired) from speaking at an event because he is an outspoken Christian. [23](#)
 - February 2012 – The Air Force removes “God” from the patch of Rapid Capabilities Office (the

- word on the patch was in Latin: Dei). [24](#)
- February 2012 – The Army orders Catholic chaplains not to read a letter to parishioners that their archbishop asked them to read. [25](#)

3. Acts of hostility toward Biblical values:

- January 2009 – Obama lifts restrictions on U.S. government funding for groups that provide abortion services or counseling abroad, forcing taxpayers to fund pro-abortion groups that either promote or perform abortions in other nations. [26](#)
- January 2009 – President Obama's nominee for deputy

secretary of state asserts that American taxpayers are required to pay for abortions and that limits on abortion funding are unconstitutional.

- March 2009 – The Obama administration shut out pro-life groups from attending a White House-sponsored health care summit. 28
- March 2009 – Obama orders taxpayer funding of embryonic stem cell research. 29

March 2009 – Obama gave \$50 million for the UNFPA, the UN population agency that promotes abortion and works closely with Chinese population control

officials who use forced abortions and involuntary sterilizations. 30

- May 2009 – The White House budget eliminates all funding for abstinence-only education and replaces it with “comprehensive” sexual education, repeatedly proven to increase teen pregnancies and abortions. 31 He continues the deletion in subsequent budgets. 32
- May 2009 – Obama officials assemble a terrorism dictionary calling pro-life advocates violent and charging that they use racism in their “criminal” activities. 33
- July 2009 – The Obama

but when Bibles were burned by the military, numerous reasons were offered why it was the right thing to do. 52

Many of these actions are literally unprecedented – this is the first time they have happened in four centuries of American history. The hostility of President Obama toward Biblical faith and values is without equal from any previous American president. [End Article]

“Principles of mental health cannot be successfully furthered in any society unless there is progressive acceptance of the concept of world citizenship.”[1](#) The International Congress on Mental Health, 1948.

"...the subject which will be of most importance politically is Mass Psychology.... The populace will not be allowed to know how its convictions were generated. When the technique has been perfected, every government that has been in charge of education for a generation will be able to control its subjects securely without the need of armies or policemen. As yet there is only one country which has succeeded in creating this politician's paradise."2 **Bertrand Russell**, *The Impact of Science on Society*

Would the American people allow government control and collectivism to replace freedom and individualism? You bet! So would the rest of the world. This social transformation is well under way, and the masses simply flow with the change.3 " [See "[Brainwashing in America](#)"]

Planned over a century ago, the framework for managing and monitoring this worldwide revolution was in place by 1945. Like the mythical Phoenix rising out of its ashes, the United Nations emerged from the fiery devastation of World War 2 as a beacon of light to utopian humanists and their hopeful followers. Within a year after

Communist leader Alger Hiss presided over its birth, some of its most powerful agencies had been established. Julian Huxley (brother of Aldous) led the UN Educational, Scientific and Cultural Organization (UNESCO). And Canadian psychiatrist Brock Chisholm laid the foundation for the World Health Organization (WHO).

The two socialist Director-Generals shared a common vision of a tightly controlled global community, but Dr. Chisholm summarized it best. Ponder his words, for they exposed a global plan for "peace" designed to conform the "mental health" of all

people to his radical mission. "

Notice the villains in this crusade:
"The responsibility for charting the necessary changes in human behavior rests clearly on the sciences working in that field. Psychologists, psychiatrists, sociologists, economists, and politicians must face this responsibility....

"Can we identify the reasons why we fight wars...? Many of them are easy to list -- prejudice, isolationism, the ability to emotionally and uncritically to believe unreasonable things....

"The only psychological force capable of producing these perversions is morality, the concept of right and wrong... "For

many generations we have bowed our necks to the yoke of the conviction of sin. We have swallowed all manner of poisonous certainties fed us by our parents, our Sunday and day school teachers....

"...it has long been generally accepted that parents have perfect right to impose any points of view, any lies or fears, superstitions, prejudices, hates, or faith on their defenseless children. It is, however, only recently that it has become a matter of certain knowledge that these things cause neuroses, behavior disorders, emotional disabilities, and failure to develop to a state of emotional

maturity which fits one to be a citizen of a democracy....

"Surely the training of children in home and schools should be of at least as great public concern as their vaccination for their own protection.... "Individuals who have emotional disabilities of their own, guilts, fears, inferiorities, are certain to project their hates on to others... They are a very real menace... Whatever the cost, we must learn to live in friendliness and peace with... all the people in the world...."

"There is something to be said... for gently putting aside the mistaken old ways of our elders if that is possible. If it cannot be

done gently, it may have to be done roughly or even violently.[4](#)
Those "poisonous certainties" include all the unchanging truths and values that can't be compromised. That's why Biblical Christianity was -- and continues to be -- incompatible with the world's standards for mental health. Many who refuse to conform to the evolving guidelines for tolerance, inclusiveness, group dialogue and adaptability to the UN plan for "continual change" are facing severe consequences.[5](#)

A WHO (World Health Organization) agency named "Nations for Mental Health" was

established to guide the national branches of this global network founded by Dr. Chisholm. Its website tells us that "Governments will be assisted to formulate, implement, monitor and evaluate mental health policies...." These "policies should enable all individuals whose mental health is disturbed or whose psychological balance may be compromised to obtain services adapted to their needs, and to promote the optimal development of the mental health of the population."[6](#)

Do you wonder how nations will define, measure, monitor and promote "the optimal mental health of the population"? It starts with subtle, even secret,

legislation. Back in 1960, Dr. Lewis Alesen, former surgeon and president of California Medical Association, wrote this timely warning:

"... the proponents of the mental health program have been quick to elaborate a series of legislative proposals.... This is the age-old subterfuge of the collectivist, whose only solution for any problem, be it economic, social or political, is the passage of another law, the imposition of another tax, and the establishment of another bureau."7

He is right. Year after year, new laws that widen the web of surveillance -- and new regulations that ban "hate,"

"intolerance" and other broad and ambiguous threats to [solidarity](#) -- have been building an inescapable framework for control.

"We have a clear blueprint in place," announced Surgeon-General David Satcher at the "National Healthy People Consortium" meeting in 1998.

"Currently, 47 states are actively involved in Healthy People 2000 and 'Healthy City and Healthy Community' initiatives are being pursued throughout the country. Hundreds of national organizations have reviewed the Year 2000 objectives and have adopted them as their own. ... No priority yet has generated as much

interest and enthusiasm as this one on mental health..."

"...our efforts will be focused on maintaining a system of global health surveillance," he continued.

"Healthy People 2010 is the United States' contribution to the World Health Organization's call to the nations of the world to renew their commitment to health for all."8 [Emphasis added]

On April 29, 2002, President George W. Bush added his support to this massive network by signing an [Executive Order](#) with the misleading title, "President's New Freedom Commission on Mental Health." It established a commission which bound the Departments of Health and

Human Services, Education and Labor together in a common quest for "the desired outcomes of mental health care, which are to attain each individual's maximum level of employment, self-care, interpersonal relationships, and community participation."9

That may sound fine to some of you. After all, mental illness has devastated countless lives and families around the world. But this vast new mental surveillance and remediation program reaches far beyond actual mental illness.

Instead of informing tax-payers, its nice-sounding goals and promising titles seem designed to hide the truth, pacify the masses

and prevent opposition. In his 1960 book, *Mental Robots*, Dr. Lewis A. Alesen, described this age-old tactic:

"Most of the almost innumerable books, pamphlets, and other publications issued by the sponsors of the mental health program are purposely and craftily disingenuous, disguising its real and ultimate purpose: ... the ultimate reduction of every individual in this world, except the favored few who conceive of themselves as possessed of an incomparable genius in their ability to direct the affairs of others, into... a common servile obeisance to his master, the State...."[10](#)

President Bush assures us that his new "Freedom Commission" (subtitled "Achieving the Promise: Transforming Mental Health Care in America") would "follow the principles of [Federalism](#)." Instead, it actually paves the way for an official cradle-to-grave behavioral modification and monitoring system that would turn those wise federalist principles upside-down. To "ensure that its recommendations would promote innovation, flexibility, and accountability at all levels of government" this Commission need only "respect" -- not accept or acknowledge -- "the constitutional role of the States."

That's not the Federalism guaranteed in our Constitution.[11](#) Eight months after President Bush signed this Executive Order, his new "Freedom Commission on Mental Health" presented its report. Like the [Homeland Security Act](#), the report focused on "**prevention.**" To globalist managers who would conform our thinking to a communitarian ideal, **prevention** implies a continual program of assessing, monitoring and molding every mind -- before any evidence of "unhealthy" thinking appears. The following excerpts from its "Goal 4: Early Mental Health Screening, Assessment and Referral to Services" presents the persuasive

"scientific" evidence needed to gain public support:

"New understanding of the brain indicates that early identification and interventions can sharply improve outcomes and that longer periods of abnormal thoughts and behavior have cumulative effects and can limit capacity for recovery....

"Since children develop rapidly, delivering mental health services and supports early and swiftly is necessary to avoid permanent consequences and to ensure that children are ready for school. Emerging neuroscience highlights the ability of environmental factors to shape

brain development and related behavior...

"Early interventions, such as the Nurse-Family Partnership,[12](#) and educational efforts can help a greater number of parents, the public, and providers learn about the importance of the first years of a child's life and how to establish a foundation for healthy social and emotional development."

"A coordinated, national approach to these issues will help eliminate social and emotional barriers to learning.... More effort is needed to heighten public awareness of the developmental requirements for children's social and emotional well-being...."[13](#)

What is meant by "eliminate social and emotional barriers to learning"? Might it include Christian faith and a Biblical view of right and wrong? Or parental objections to government interference? [12](#) Or the constitutional rights that protect religious freedom?

If so, it would match Dr. Chisholm's blueprint for "mental health." You read some of the excerpts earlier. In that 1946 message (quoted earlier), the WHO pioneer asked, ""Can such a program of re-education... be charted?"

"The answer is yes, and each year brings us closer to this sobering reality.

But we shouldn't be surprised. The Bible describes a time ahead when His people will face unthinkable hatred and persecution from a world government determined to wipe out Biblical Christianity and all other obstacles to its absolute control. When that time comes, there will be only one place to hide: in Jesus Christ. Between now and then, let's pray for God's guidance and seek to awaken as many people as possible to the coming challenges to faith and freedom.
